- Zoom links will be provided, and will be included in the final conference program. We expect to e-mail out the final conference program shortly before the conference starts. If you chair one of the in-person sessions

Any individual who sends advertising messages will be promptly removed from the meeting. ## School of Business Administration

### Zhongnan University of Economics and Law

**Zhongnan University of Economics and Law (ZUEL)** is an institute of higher education directly administrated by the Ministry of Education of the People's Republic of China with economics, law and management as its core disciplines and coordinated with other six disciplines including philosophy, literature, history, science, engineering, and arts. ZUEL is also one of the universities sponsored by National “211 project” and “985 Project Innovation Platform”, and has been selected into the list of universities and colleges of world-class universities and world-class disciplines.

The history of the School of Business Administration (SBA) of ZUEL can be traced back to 1949 when the Department of Factory Management and the Department of Trade were established at Zhongyuan University. In 2018, The MBA School of ZUEL was merged into SBA, making it step into a new history.

The school offers programs in two first-level disciplines: *Business Administration* and *Applied Economics*, including 8 doctoral programs, 15 master's programs, and 10 undergraduate programs.
