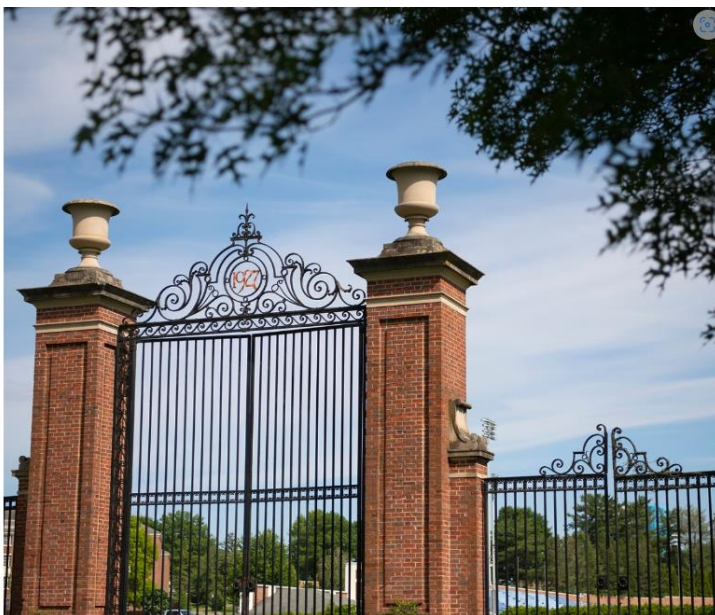

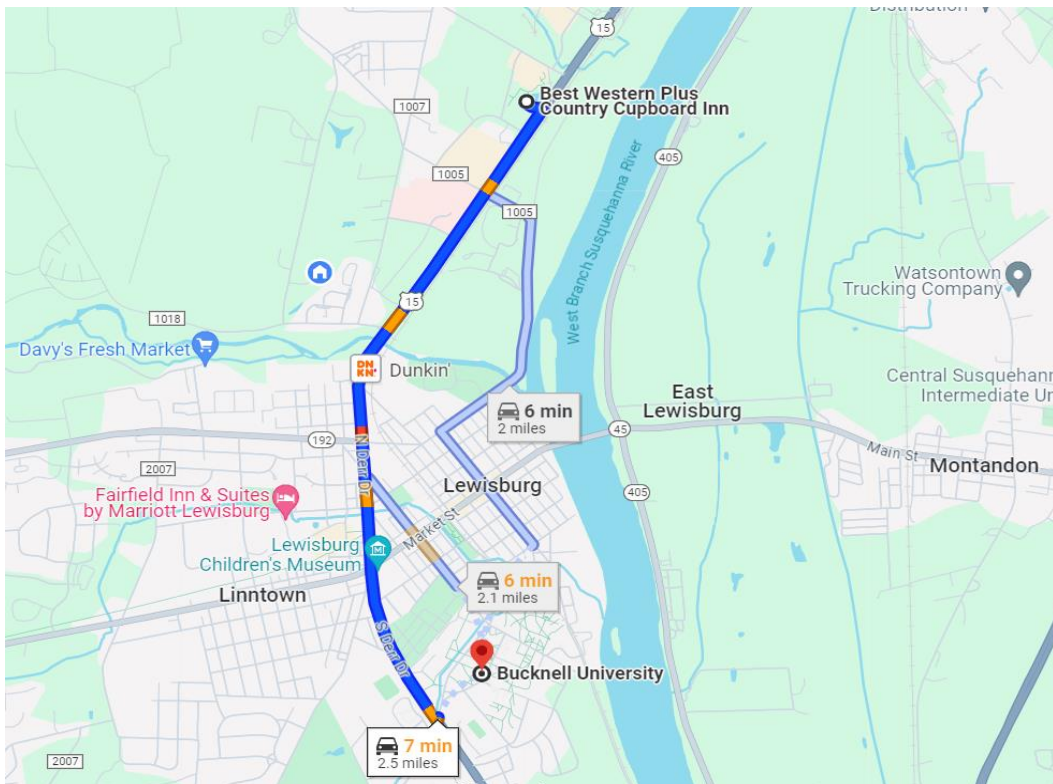

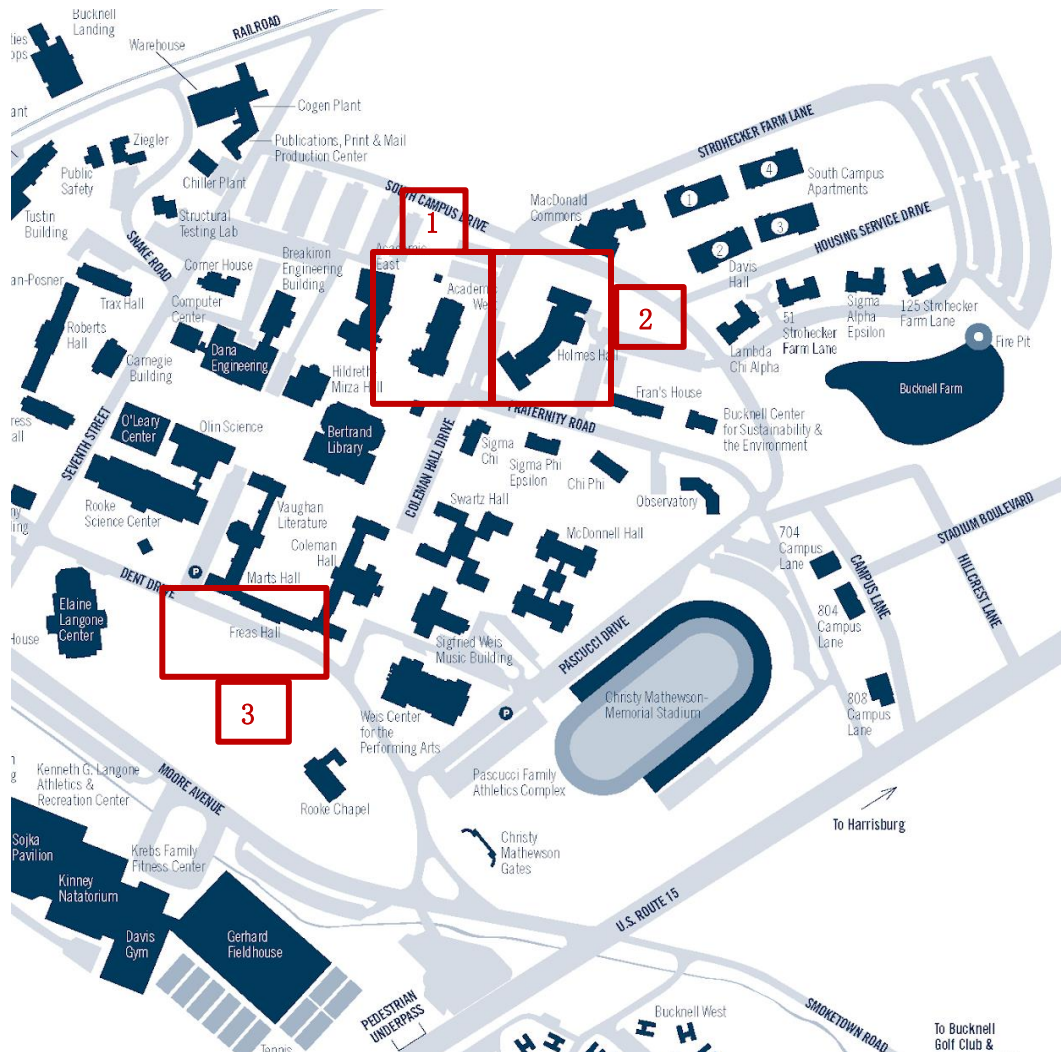

## **Our Institutional Members**

### **Beijing University of Technology**

#### **北京工业大学经济与管理学院**

北京工业大学经济与管理学院成立于 1997 年,下设管理科学与工程、应用经济、工商管理三个系,涵盖管理学和经济学两大门类,有管理科学与工程和应用经济学 2 个一级学科博士学位授权点,资源环境与循环经济交叉学科博士学位授权点,工商管理一级学科硕士学位授权点,以及工商管理硕士(MBA)、公共管理硕士(MPA)、会计硕士(MPAcc)、金融硕士(MF)等 4 个专业硕士学位点。学院现有大数据管理与应用、信息管理与信息系统、国际经济与贸易、经济统计学、金融学、会计学、工商管理等 7 个本科专业,其中信息管理与信息系统、国际经济与贸易、会计学为国家级一流本科专业建设点,经济统计学、金融学为北京市一流本科专业建设点。

截止 2023 年 2 月经管学院现有教职工 205 人,其中专任教师 166 人,教师中有正高职称者 33 人,副高职称者 70 人。学院在校学生共计 2166 人,其中本科生 1371 人、硕士研究生 717 人、博士研究生 78 人。

The College of Economics and Management in Beijing University of Technology was established in 1997. It consists of three departments, Management Science and Engineering, Applied Economics and Business Administration, which covers two major disciplines of management and economics. There are two first-level disciplines of doctoral degree authorization for Management Science and Engineering and Applied Economics, a cross-disciplinary doctoral degree authorization for Resource Environment and Circular Economy, and a first-level discipline of master's degree authorization for Business Administration. There are 4 professional master's degree programs, including Master of Business Administration (MBA), Master of Public Administration (MPA), Master of Accounting (MPAcc) and Master of Finance (MF). There are 7 undergraduate majors in the College, including Big Data Management and Application, Information Management and Information System, International Economics and Trade, Economic Statistics, Finance, Accounting and Business Administration, among which Information Management and Information System, International Economics and Trade, and Accounting are national first-class undergraduate major construction programs, and Economic Statistics and Finance are Beijing first-class undergraduate major construction programs.

As of February 2023, the College of Economics and Management has 205 faculty members, including 166 full-time teachers, 33 of whom have senior titles and 70 of whom have associate titles. There are 2166 students in the College, including 1371 undergraduates, 717 master's degree students and 78 doctoral degree students.

Minzu University of China built by the State Ethnic Affairs Commission, the Ministry of Education and Beijing. The University entered the national “Project 211” and “Project 985” in 1999 and 2004 respectively; and was included in the list of “Double Top” Class A universities in 2017.

The School of Economics at Minzu University of China has four departments: Economics; International Economics and Trade; Finance; Public Finance. Together, these cover two first-level disciplines of theoretical economics and applied economics, and one second-level disciplines of China Minority Economics.

By now, the School has 62 full-time faculty members, including 21 professor, 24 associate professor, and 18 doctoral supervisors. School of Economics (SOE) at Hefei University of Technology was founded in 2011. The school has a teaching and office area of 5,000 square meters, with departments including the Department of Economics, International Economics and Trade, Financial Engineering, and Economics and Trade (Xuancheng Campus). There are five educational support centers including the International Education Center (IEC), the Experimental Teaching Center, the Master of Finance Education Center, the Academic Exchange Center, and the School-Enterprise Cooperative Education Center. The school has 1,413 undergraduate students, 19 foreign students, and 385 graduate students.

The school has 7 research institutes, including Institute of Digital Economy and Innovation, Institute of Economic Development, Institute of Finance, Institute of Industrial Economics, Institute of Innovative Economics, Institute of International Trade and Investment, Institute of Quantitative Economics, and Institute of Regional Economics. Over 100 high-level papers have been published in well-known domestic journals such as Economic Research Journal, Management World, Journal of World Economy and China Economic Quarterly, as well as internationally renowned journals such as China Economic Review, Environmental and Resource Economics, Operations Research, Technovation and Transportation Policy.

### 重庆大学经济与工商管理学院

School of Economics and Business Administration (SEBA), Chongqing University was founded in 1937. The first full-time dean was Professor Ma Yinchu, one of China's most famous economists with a doctorate degree from Columbia University, USA. In the 1930s to 1940s, the school was one of the most renowned business schools in China. From 1993, it began awarding PhDs and subsequently was granted the first national key discipline of its kind in southwest China. According to ARWU (Shanghai Ranking's Academic Ranking of World Universities) ranking system, SEBA is ranked 15<sup>th</sup> (top 5%) in China.

Currently, SEBA has 2 doctoral programs, 2 MSc programs and 4 professional master programs (MBA, MPAcc, MF and MIB) which enroll about 800 students in total every year. The MBA program began in 1997 and has produced nearly 4,000 MBA graduates who made significant contributions to the economic and social development of west China. The MBA program is now among the best in China according to latest national-wide evaluation. In the list of 2023 The Best TOP 100 MBA Programs in China, the MBA program of CQU is ranked 11<sup>th</sup>. SEBA has 136 full-time faculty members and 62 of them are professors, 53 are associate professors. SEBA also invites more than 150 professionals including senior managers, accounting and finance professionals from the industry and government departments to be part-time advisors for students. They come to teach, supervise or give lectures to students, and facilitate core faculty members to be closely connected with the industry and society.

SEBA was accredited by AMBA in September of 2013, by AACSB in 2017 and by EQUIS in 2021. Now SEBA is making strides towards the goal of becoming a top class business school in China with international fame through continuous quality improvement.

东南大学商科历史可以追溯到 1917 年成立的南高师商业专修科。1985 年 1 月，南京工学院管理科学与工程系成立。1987 年 8 月，南京工学院以管理科学与工程系、自动化研究所的系统工程研究室、社会科学系的工业经济教研室为基础，成立南京工学院管理学院。1991 年 9 月，东南大学经济贸易系并入，学院更名为东南大学经济管理学院。历经商科百余年、建院近四十年的发展，目前学院已成为东南大学专业门类最多、学生规模最大的学院之一。学院秉承“创新才有未来”的办学理念，肩负“育胸怀天下英才，铸通达古今新知”使命，以学科建设为龙头，以立德树人为中心，聚焦国家重大战略需求，倾心力育英才，顶天立地做科研，为实现“桃李天下皆有为”的学院愿景，锐意进取、开拓创新，持续推动学科建设、人才培养、师资队伍建设、科学研究、社会服务和国际化办学等方面的高质量发展。

经济管理学院横跨经济学和管理学两大学科门类，拥有管理科学与工程、应用经济学、工商管理 3 个一级学科博士学位授权点；管理科学与工程、应用经济学、工商管理 3 个一级学科博士后流动站和江苏省优势建设学科；建有管理科学与工程、应用经济学、工商管理 3 个一级学科硕士学位授权点；还有管理学类（信息管理与信息系统、工商管理、会计学、电子商务、物流管理）、经济学类（国际经济与贸易、金融学、经济学、金融工程）2 个本科专业类。学院着力加强学科建设，学科水平保持“管理科学与工程” A-（全国前 10%）、“应用经济学” B+、“工商管理” B+（全国前 20%）的优势地位。

经济管理学院长期以来高度重视国际化合作办学，已与国外三十多所大学建立了长期友好的合作关系，参与东南大学-蒙纳士大学苏州联合研究生院、东南大学-雷恩一大研究生院建设，邀请包括诺贝尔经济学奖得主在内的国际一流知名专家学者来院讲学，建有 30 多门全英文课程、双语课程，覆盖全部本科专业。学院每年派出教师 30 余人次赴国（境）外参加国际学术会议，每年有一批本科生出国深造。国际化办学已经成为学院拓展师生视野、提高人才培养质量和科学研究水平的重要途径。

# Wuhan University

### 武汉大学经济与管理学院

武汉大学经济与管理学院是学校办学规模最大的学院，也是学校综合实力领先、社会影响最大的学院之一。

办学历史悠久，学术积淀深厚。其前身可追溯到 1893 年清末湖广总督张之洞创办自强学堂时设立的商务门，其实体根基源自 1916 年设立的国立武昌商业专门学校。1928 年国立武汉大学设经济学系。2001 年原武汉大学商学院、原武汉水利电力大学经济管理学院与原武汉测绘科技大学经济管理、市场营销教研室合并组建新武汉大学商学院，2005 年更名为经济与管理学院。

学科门类齐全，专业优势突出。学科涵盖经济与管理两大门类，拥有四个一级学科：理论经济学、应用经济学、管理科学与工程、工商管理，四个一级学科全部具有一级学科博士学位授予权并都设有博士后科研流动站。理论经济学两次入选国家“双一流”学科建设名单，理论经济学一级学科、金融学二级学科是国家重点学科；全部学科为湖北省优势或重点学科。在第五轮学科评估中，四个一级学科均进入 A 类学科。武汉大学经济学与商学进入 ESI 全球前 1%。先后通过 AMBA、EQUIS、AACSB 三大国际认证。在 QS 世界大学学科排名中，武汉大学经济与计量经济学学科位列世界第 147 名。经济发展研究中心是教育部人文社会科学研究百所重点研究基地之一。拥有 2 个国别和区域研究中心（教育部备案）、2 个部校共建机构、5 个湖北省人文社会科学重点研究基地。

师资力量雄厚，梯队结构合理。现有专任教师 260 人，其中国家高层次人才 15 人次、省市高层次人才 18 人次，学校人文社科杰青 5 人，学校人文社科优青 4 人，学校驻院研究员 7 人，教授、特聘研究员 98 人，副教授、副研究员、特聘副研究员 121 人。

组织机构健全，办学条件良好。现有 12 个系（所）及若干学术研究中心（所），内设 7 个行政管理办公室、2 个教辅单位。现有 8 个国家一流本科专业，7 门国家一流本科课程，经济学拔尖学生培养基地为教育部基础学科拔尖学生培养计划 2.0 基地。经济与管理实验教学中心为国家级实验教学示范中心，主办《经济评论》是国家社科基金资助期刊、CSSCI 来源期刊、全国中文核心期刊、中国人文社会科学期刊 AMI 综合评价核心期刊，主办《珞珈管理评论》为 CSSCI 来源集刊、中国人文社会科学期刊 AMI 综合评价核心集刊。

办学规模宏大，优秀人才辈出。现有在籍学生约 6700 人，其中本科生约 2500 人、学术学位研究生约 1400 人、专业学位研究生约 2800 人，各类国际学生约 300 人。学院始终以博习会通、传承文化、培育菁英、经世致用为己任，始终把人才培养质量放在首位。学生在国内外学术科技及文体竞赛中屡获佳绩，每年近 7 成本科生毕业后继续深造，研究生毕业落实率高达 95%，历届毕业生德智双彰，涌现出大批政界、学界、商界杰出人才，17 位校友当选武汉大学杰出校友。
